The Illinois Bar Foundation and The Chicago Bar Foundation seek interested and qualified individuals to serve as Illinois JusticeCorps Members for the 2021-2022 program year. Illinois JusticeCorps members provide valuable assistance to people without lawyers by helping them navigate the courthouse, access legal and social resources, and connecting them to legal aid and other services. JusticeCorps complements the work of lawyers, clerks and library staff by providing legal information and procedural guidance to those who need it most.

Volunteer responsibilities may include:

- Providing legal information and connecting court patrons to available legal aid resources
- Accompanying people without lawyers around the courthouse to help them complete the necessary steps to move forward with their legal matters

The position requires:

- Make a 300-hour commitment as an AmeriCorps member. All hours must be completed within 1 year of start date or by December 31, 2022, whichever comes first. *Program runs August 1, 2021 December 31, 2022*
- Preference given to candidates who can commit to serving at least 8-10 hours a week, during court hours
- Attend all training sessions and other events to learn the facts needed to give accurate information
- Attend required National Days of Service and Member Recognition Day
- Conscientiously gather and submit data needed for reports
- Non-English Language proficiency a plus

Benefits:

- After completion of 300-hour commitment, volunteer will receive an Education Award for tuition payment or student loan repayment in the amount of \$1,342.86
- Great professional skills development, work experience, and professional references

300-Hour Minimum-Time (Part-Time Volunteer) Commitment

POSITION REQUIREMENTS

To be considered for a volunteer position, you will need to meet some initial eligibility requirements. Before applying, please carefully review the following to make sure you qualify:

□ Age Requirement

- Applicants must be 18 years of age or older.
- Applicants must submit a copy of their driver's license, state identification card, or passport to prove their age.

D Education Requirement

- Applicants must have a high school diploma or GED.
- Applicants must certify on application that they have received a high school diploma or GED.

□ Citizenship/Residency Requirement

- Applicants must be U.S. Citizens or Lawful Permanent Residents.
- Applicants must submit a copy of one of the following to prove citizenship/residency:
 - Birth certificate showing birthplace in the U.S., Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, or the Northern Mariana Islands;
 - U.S. passport;
 - Report of a birth abroad of a U.S. citizen issued by the U.S. Department of State;
 - Certification of a birth abroad issued by the U.S. Department of State;
 - Certificate of Naturalization issued by U.S. Citizenship & Immigration Services (USCIS);
 - Certificate of U.S. Citizenship issued by USCIS;
 - Lawful Permanent Resident card issued by USCIS;
 - Alien Registration card receipt issued by USCIS;
 - Passport indicating that USCIS has approved it as a temporary evidence of admission for permanent residence.

D Criminal Background Check Requirement

- Applicants must consent to and pass the following criminal background checks:
 - Search of the National Sex Offender Registry;
 - Fingerprint search of the Illinois State Police registry and the state in which you reside if it is not Illinois;
 - Fingerprint search of the FBI's national criminal history database.

D Time Commitment Requirement

• Applicants must commit to serving approximately eight to twelve hours per week or more in order to complete 300 hours of service within one year of their start date or by December 31, 2022, whichever comes first.

Training Commitment Requirement

• Applicants must commit to attending a pre-service orientation as well as any other mandatory training and AmeriCorps member events during their term of service.
